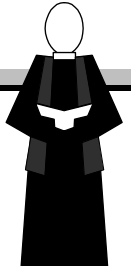

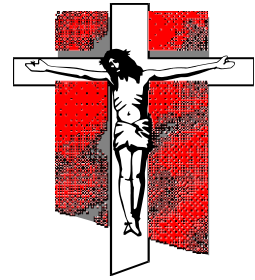

Dear Brother Knights,

It was great to see so many families at our Christmas Party.

Congratulations to Richard Higgins for having his name drawn for the Good of the Order drawing in December. Unfortunately, he wasn't present to collect \$10.00.

Dues Statements for 2020 calendar year have been sent out. In addition to our \$32.00 dues, there are 3 special assessments included. If you are having financial difficulties in paying your dues, please contact either myself or Grand Knight Rolly Arenz, as we can help you remain a Council Member in good standing.

The 1st special assessment is for **Columbian Charities**, in the amount of only **\$3.65**. **California Columbian Charities, Inc.** is dedicated to assisting California Brothers in financial distress, including their widows. For sixty-five years it has worked to provide CHARITY, the first principle of our Order, and to fulfill Father McGivney's mandate of BROTHER HELPING BROTHER. It has responded to almost 2100 requests for assistance from Brother Knights in California and has given over \$3,000,000 in relief. Columbian Charities provides financial assistance to Knights of Columbus Brothers, with at least twelve months good standing in a California Council; and to their widows and orphans, by helping to relieve financial distress due to unemployment, sickness, family medical and hospital bills, overdue rent or mortgage payments, property tax, food, clothing, losses due to fire, flood or earthquake. All the financial assistance provided is a grant and need not be repaid. *If you know a Brother Knight who is in need of assistance, contact our Grand Knight, who can obtain a Charity application from the California State Council office. So please include the \$3.65 added to your dues.*

The 2nd is the Knights of Columbus **Culture of Life Fund**, is a permanent fund established by a vote of the delegates to the 2008 Supreme Convention in Quebec City. As of December 2016, the initiative has funded and placed 829 ultrasound machines, valued at more than \$40 million, in all 50 states, as well as in Canada, Jamaica, Guatemala and Peru, and helped save the lives of thousands of babies. So please include the **\$2.00** added to your dues.

The 3rd is **Council Brothers in Financial Difficulty**, which is a Council fund established last year following the founding Principle of our Order, Charity, to assist Council Brothers in financial difficulty in keeping their dues current. So please include the **\$5.00** added to your dues. Remember to get your **Fraternal Activities Survey** turned in by the January Meeting, as it is needed by Supreme Council for documentation for the IRS. We will hold a drawing where the winner whose dues were paid by will have his 2019 dues refunded. I hope to see you all there.

Planned Parenthood Lawsuit Tries to Punish Pro-Lifers Who Exposed Its Baby Part Sales as Criminals



NATIONAL CHERYL SULLENGER WASHINGTON, DC

Troy Newman and three of his co-defendants will walk into Judge William Orrick's Federal courtroom and begin their defense against Planned Parenthood's accusations against them in the biggest pro-life trial in two decades.

Planned Parenthood brought the case against Newman, Susan Merritt, David Daleiden, the Center for Medical Progress, and the CMP's alter-ego, Biomax, in 2016, after the release of a [series of undercover videos](#) that revealed Planned Parenthood's participation in the illegal trafficking of aborted baby remains for profit.

In an ironic twist, instead of Planned Parenthood being held accountable, the largest abortion organization in America have brought the pro-life journalists to court and accused *them* of corruption and racketeering.

The American Center for Law and Justice (ACLJ) is representing Newman in this case, who was sued due to his service as a board member of the Center for Medical Progress during the three-year undercover investigation.

Why this case is important

Despite the Planned Parenthood case and an earlier lawsuit filed by the National Abortion Federation (which is currently on hold until the conclusion of the Planned Parenthood case), the CMP investigation was a game-changer.

The ACLJ [wrote](#): In light of CMP's investigative reporting, the United States Senate and House of Representatives conducted thorough investigations into illegal, unethical, and immoral practices within the abortion and fetal tissue procurement industries.

The expose videos catching Planned Parenthood officials allegedly selling the body parts of aborted babies have shocked the nation.

Here is a list of all 14:

[In the first video](#): Dr. Deborah Nucatola of Planned Parenthood commented on baby-crushing: "We've been very good at getting heart, lung, liver, because we know that, so I'm not gonna crush that part, I'm gonna basically crush below, I'm gonna crush above, and I'm gonna see if I can get it all intact."

[In the second video](#): Planned Parenthood's Dr. Mary Gatter joked, "I want a Lamborghini" as she negotiated the best price for baby parts.

In the third video: Holly O'Donnell, a former Stem Express employee who worked inside a Planned Parenthood clinic, detailed first-hand the unspeakable atrocities and how she fainted in horror over handling baby legs.

In the fourth video: Planned Parenthood's Dr. Savita Ginde stated, "We don't want to do just a flat-fee (per baby) of like, \$200. A per-item thing works a little better, just because we can see how much we can get out of it." She also laughed while looking at a plate of fetal kidneys that were "good to go."

In the fifth video: Melissa Farrell of Planned Parenthood-Gulf Coast in Houston boasted of Planned Parenthood's skill in obtaining "intact fetal cadavers" and how her "research" department "contributes so much to the bottom line of our organization here, you know we're one of the largest affiliates, our Research Department is the largest in the United States."

In the sixth video: Holly O'Donnell described technicians taking fetal parts without patient consent: "There were times when they would just take what they wanted. And these mothers don't know. And there's no way they would know."

In the seventh and perhaps most disturbing video: Holly O'Donnell described the harvesting, or "procurement," of organs from a nearly intact late-term fetus aborted at Planned Parenthood Mar Monte's Alameda clinic in San Jose, CA. "'You want to see something kind of cool,'" O'Donnell says her supervisor asked her. "And she just taps the heart, and it starts beating. And I'm sitting here and I'm looking at this fetus, and its heart is beating, and I don't know what to think."

In the eighth video: StemExpress CEO Cate Dyer admits Planned Parenthood sells "a lot of" fully intact aborted babies.

The ninth video: catches a Planned Parenthood medical director discussing how the abortion company sells fully intact aborted babies — including one who "just fell out" of the womb.

The 10th video: catches the nation's biggest abortion business selling specific body parts — including the heart, eyes and "gonads" of unborn babies. The video also shows the shocking ways in which Planned Parenthood officials admit that they are breaking federal law by selling aborted baby body parts for profit.

Unreleased Videos: Unreleased videos from CMP show Deb Vanderhei of Planned Parenthood caught on tape talking about how Planned Parenthood abortion business affiliates may "want to increase revenue [from selling baby parts] but we can't stop them..." Another video has a woman talking about the "financial incentives" of selling aborted baby body parts.

The 11th video: catches a Texas Planned Parenthood abortionist planning to sell the intact heads of aborted babies for research. Amna Dermish is caught on tape describing an illegal partial-birth abortion procedure to terminate living, late-term unborn babies which she hopes will yield intact fetal heads for brain harvesting.

The 12th video in the series shows new footage of Jennefer Russo, medical director at Planned Parenthood in Orange County, California, describing to undercover investigators how her abortion business tries to harvest intact aborted babies' bodies for a local for-profit biotech company and changes the abortion procedure to do so.

The 13th video: exposes a Planned Parenthood medical director admitting that babies born alive after abortion are sometimes killed.

The 14th video: catches Planned Parenthood executives discussing gruesome abortion procedures and the sale of body parts from aborted babies for profit.

Recently, I have been reading a very interesting book called the “Spirituality of Imperfection”. The book opens with the following quote from a commissioner of Baseball.

*“Baseball teaches us, or has taught most of us, how to deal with failure. We learn at a very young age that failure is the norm in baseball and, precisely because we have failed, we hold in high regard those who fail less often—those who hit safely in one out of three chances and become star players. I also find it fascinating that baseball, alone in sport, considers errors to be part of the game, part of its rigorous truth.”**

The authors go on to modify this quotation to indicate how much of our spiritual journey can be explained through this analogy:

*“Spirituality teaches us, or has taught most of us, how to deal with failure. We learn at a very young age that failure is the norm in life ... errors are part of the game, part of its rigorous truth.”**

Of course, we are all broken in some way, but the lesson here of learning that much of our development and movement in our lives, comes from making errors can also be applied to the spiritual journey. We are all imperfect in some way, and yet God still loves us.

When I review my own spiritual journey over the years, I can see much of the change, at least the positive changes, occurred when I had recognized when I had failed in my relationship with God and others. The forgiveness which is there for us through the sacrament of Reconciliation and God’s unconditional love for us helps us to heal and move closer to Him.

Diocese of Orange Requirement for Safe Environment Training

The Diocese of Orange now require that members of the Knights of Columbus who volunteers their talents and services to our parish that involves minors must complete Safe Environment (SE) training and background screening via Live Scan Digital Fingerprinting.

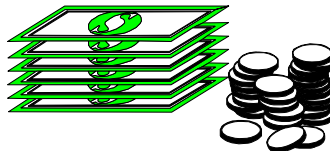
