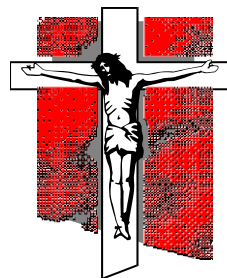

Our election of Officers for the 2020-2021 Columbian Year will be held during our June Business Meeting online on Zoom. Be sure to login and make your vote and voice heard.

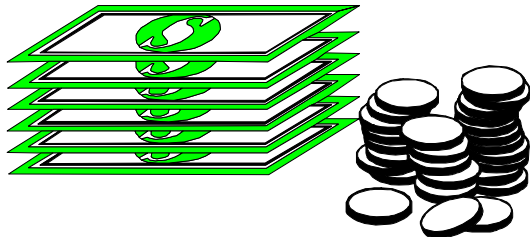

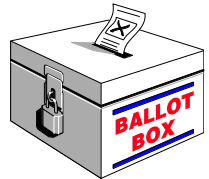

## Planned Parenthood Opens Huge Secret Abortion Center Outside St. Louis, Built Under Fake Name

Planned Parenthood is opening a huge new abortion business on the border of Illinois and Missouri after keeping it secret for a year.

[CBS News reports](#) the new mega-clinic is located in Fairview Heights, Illinois, just 13 miles away from St. Louis, Missouri. The abortion chain also hopes to sell abortions to women in Kentucky and Arkansas at the new facility.

Planned Parenthood is the largest abortion business in the U.S. Last year, it reported [a record \\$1.66 billion in revenue](#) and more than 330,000 abortions, even as patient numbers fell. Abortion is its main business, and Colleen McNicholas, the chief medical officer of Planned Parenthood of the St. Louis Region and Southwest Missouri, said they hope to see 11,000 patients annually at the Fairview Heights facility.

She admitted that they worked hard to keep the new building a secret from the local community.

According to CBS: “Since August 2018, Planned Parenthood has used a shell company to construct the facility, leaving no public trace that the former medical office would become one of the largest abortion clinics in the country. CBS News first visited the site in August, while it was still being built.” McNicholas tried to justify these deceptions by describing past experiences with building projects. She told CBS that some companies and contractors refuse to work with them after learning that they are an abortion business, and pro-life advocates in the communities protest their plans. She said they built the new mega-abortion facility under the code name “Alaska.” It cost about \$7 million to build, and it will begin seeing patients within the next few weeks.

It is not clear how far along abortions will be performed. Illinois allows unborn babies to be aborted for basically any reason up to birth, and McNicholas has defended them. In August, she [told the AP](#) that “EVERY reason to have an abortion is a valid reason,” including for sex-selection and disabilities like Down syndrome.

Here’s more from the report:

With the opening of the mega-clinic nearby, they’ll be able to expand [abortion] services, said McNicholas, who added that Planned Parenthood was expanding its staffing in the region to handle both family planning and abortion services. The new facility will roughly double the existing clinic’s capacity, with the ability to serve up to 11,000 patients a year, said a spokesperson for Planned Parenthood.

Even though the new facility could absorb all of St. Louis's patients if the clinic has to stop performing abortions, McNicholas said the new clinic doesn't mean they're giving up on Missouri. Steven Aden, Chief Legal Officer and General Counsel of Americans United for Life, told LifeNews.com he's not surprised by the news.

"How appropriate that Planned Parenthood has built a secret 'mega-center' to go with its mega-sized status as America's biggest abortion business – fully one-third of all U.S. abortions are done at a Planned Parenthood facility," he said. He added: "Planned Parenthood loudly complains that long distances inhibit access to abortion while building its business model on the truth that they will. Given that abortions are falling precipitously all over the country as women are learning what abortion really is and does to them and their babies, the main impact of this new mega-center might be to drive Planned Parenthood St. Louis – just across the river – out of business. In light of the fact that the St. Louis abortion center has sent 74 women directly to the hospital over the last ten years, that can only be a very good thing for women in both Missouri and Illinois."

The St. Louis Planned Parenthood has [a horrendous record of health and safety violations](#). Earlier this year, state health officials tried to revoke its license, but Planned Parenthood sued and a judge allowed it to remain open. The state Department of Health found dozens of health and safety violations in St. Louis, and pro-life advocates have documented [72 occasions when ambulances were called to the abortion facility for women with abortion complications](#). CBS News failed to mention any of these concerns and implied that the state is just trying to close the abortion facility for political reasons.

Planned Parenthood has been secretive about new abortion clinics in the past. Last year, [a Michigan community expressed outrage after the abortion chain used a different name on paperwork](#) so that it could open a new abortion facility in secret. In Kansas, pro-life advocates recently stopped Planned Parenthood from [opening a new abortion facility right next to a high school in their community](#). It used similarly secretive tactics in the community, but pro-life advocates found out anyway.

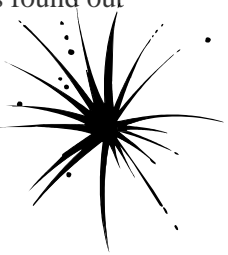

# **A Message From Your Council.....Recorder & Respect Life, Justice & Peace Chairman**



A TRUE MIRACLE  
By Frank Faecke

In April 1917 the USA entered the bloodbath known as World War I. Communists had targeted Portugal in 1910. By 1917 they had confiscated all property owned by religions, banished clergy from the country, murdered the Royal Family down to the last child, and declared religion to be the opiate of the people. Portugal was in their grasp. Lenin told Communists in Russia to wait until the Czarist armies were weakened before striking (1917.)

The thin veil between life as we know it and the life that follows death has been pierced at times. The story that unfolded in 1917 was one of those special moments.

I learned of that dramatic tale in the well-documented book entitled MEET THE WITNESSES OF THE MIRACLE OF THE SUN by John Haffert. Haffert conducted extensive research through books, newspaper articles, photographs, etc. After World War II, he conducted hundreds of interviews with eye witnesses of the event. He told of being struck by their body language, facial expressions, and consistent stories. They were reliving the event of over forty years previous as if it were yesterday.

It began on May 13, 1917, on a hill near Fatima, where Jacinta (age 7) and Francisco Marto (age 9) and Lucia dos Santos (age 10) saw a strange sight. These three uneducated mountain shepherds saw the vision of a young woman who would not identify herself but said she was “From Heaven.” She asked the children to return to the same spot near a tree on the same day of the month each month until October. Later she told them that she would reveal her identity and “Perform a public miracle so that everyone may believe.”

The poor children were disbelieved by family, clergy, and officials. Everyone tried to coerce them to stop lying about seeing the mysterious woman. Despite the pressure on them, five thousand persons were present at the third “vision,” when the woman gave them a secret and promised a miracle in October. Roughly thirty thousand witnessed the fifth “vision,” during which the October miracle was again promised.

Two months before the Miracle of the Sun, officials arrested the children and imprisoned them for two days. The cruel officials hoped to scare the children so badly that they would tell the crowds about the hoax of their “visions.” But even adult fellow prisoners supported the terrified children. After two hours in jail, Jacinta was taken to court. Under threat of being burned alive in a vat of boiling oil, the young girl stopped crying and remained silent. She was taken away. The other two children refused to talk under death threats. After two days of being held in a locked room, the three brave children were released on August 15. They had expected martyrdom. The official plot against them backfired. Now, more than ever, crowds believed them.

On October 13, 1917, a crowd of over 100,000 men, women, and children came by horse or wagon or train to the sight called Cova. Gathered were rich and poor, believers and disbelievers who slogged through heavy rain and deep mud past the National Guard who were supposed to control them. Some were wounded by soldiers' bayonets but pushed past the military. Eye witnesses saw the sun break through about noon. Suddenly, the rain stopped. The sun started to roll from one place to another and changed to blue, yellow, and all colors!

Mothers grabbed their children and prayed during the ten to twelve minute phenomenon. Fearing the end of the world as the sun moved toward the earth, both believers and non-believers confessed their sins aloud and begged God's mercy. When the sun went back into place the wind blew hard, but trees didn't move. Clothes were dried. The earth became dry.

Two days later, O SECULO ("The Century"), a principal Portuguese newspaper, carried a description by its newsmen who experienced it of how the sun danced. Before the event, O SECULO had carried government warnings to stay away from Fatima. Many atheists were converted, and soon the Soviets left power in Portugal

Why was it not the result of mass hypnosis or collective suggestion? First, it was witnessed over an area of 600 square miles by persons not in the crowd. Second, among the crowd were scientists and "unbelievers" who viewed the phenomenon not only with objectivity, but with care to protect themselves from the possibility of collective suggestion. The Catholic Church, after extensive investigation, declared it a miracle by the Blessed Mother Mary worthy of belief. Francisco died in April 1919, and Jacinta died on February 20, 1920. Both have been canonized. Sister Lucia died on February 13, 2005 and is being considered for sainthood. Millions have flocked to Fatima from all over the world, and thousands have found peace and/or cures.

Now you know "the rest of the story," as Paul Harvey would say.

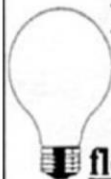
